MANDATORY RULES

1. The audio or video recordings required for the selection, will not be distributed or published and will be for the exclusive use of the Accademia Cantoalato.
2. Students must be present for the whole day and every day, otherwise the certificate will not be issued and will not be possible to sing and participate at the final concert.
3. For registration to be valid, the registration and participation fees must be paid in full on the dates indicated in the Regulations.
4. In case of withdrawal for serious reasons (after evaluation by the Organization on the gravity of the reasons communicated), the application and the attendance fee, will be returned only if the vacancy is filled by a new student, all by October 30th 2024. After this date or for any other waiver, the fees paid will not be refunded.
5. Students confirmed as effective, if decide to give up attending the Masterclas must still pay the attendance fee by the appointed date.
6. The Organization declines any responsibility for any damage to persons or property during the entire course of the Masterclass (11-15 December 2024).
7. The Organization reserves the right to make videos, audio recordings and photos during the Masterclass, and to use all the material for promotional purposes by publishing it on websites, socials, radio and television without paying fees to any participant.
8. Accademia Cantoalato - OttavaNota holds the rights of distribution, disclosure and use of audio recordings, videos, publications and/or other related to the Masterclass in question.
9. The audio and video materials given to the student are for private use (direct sending to third parties); may be used for public use (publication on social media and/ or YouTube) only with written permission issued by Cantoalato - OttavaNota.
10. Recordings (audio or video) of the lessons are allowed, exclusively for personal use. By signing the Application Form of the masterclass you accept the explicit clause of not broadcasting audio or video by any means or any tool.
11. The professional video recordings of the final concert made by Cantoalato, in agreement with Casa Verdi, is the only authorized recording.
12. The video recording of the concert by the public and/or anyone operating in private, outside the staff of Bagatti Valsecchi Museum and Accademia Cantoalato is not allowed.

Pictures of the concert that will be provided to participants, is at their disposal, with free use: it remains the obligation to mention in every communication (social or other) the ACCADEMIA CANTOALATO. It remains beyond the obligation to indicate the name of the Maestro at the piano in the photos/videos in which he appears.
14. The singers who will participate in the final concert will be selected at the discretion of the artistic staff.

15. Every decision is at unquestionable discretion of the teachers.

POLICY ON THE TREATMENT OF PERSONAL DATA

Pursuant to Article 13 of the GDPR (EU) 2016/679, OttavaNota Association, as Data Controller, with this information we intend to provide a series of information regarding the modalities of protection of personal data.
