2. Students must be present for the whole day and every day, otherwise the certificate will not be issued and and will not be possible to sing and participate at the final concert.

3. For registration to be valid, the registration and participation fees must be paid in full on the dates indicated in the Regulations.

4. In case of withdrawal for serious reasons (after evaluation by the Organization on the gravity of the reasons communicated), the participation fee, both for actual pupils and auditors, will be returned only if the vacancy is filled by a new student, all by January 7th, 2025. After this date or for any other waiver, the fees paid will not be refunded.

5. The Organization declines any responsibility for any damage to persons or property during the entire course of the Masterclass (18-23 January, 2025).

6. The Organization reserves the right to make videos, audio recordings and photos during the Workshop, and to use all the material for promotional purposes by publishing it on websites, socials, radio and television without paying fees to any participant.

7. Accademia Cantoalato - OttavaNota holds the rights of distribution, disclosure and use of audio recordings, videos, publications and/or other related to the Workshop in question.

8. The audio and video materials given to the student are for private use (direct sending to third parties); may be used for public use (publication on social media and/ or YouTube) only with written permission issued by Cantoalato - OttavaNota.


